The Lion Training Passport is an industry led partnership between the British Egg Industry Council, Poultec Training and Lantra. The partnership was established to develop minimum training requirements for each role of the UK Lion egg sector and develop an online training recording system.

All staff employed on UK Lion egg farms or hatcheries can register on the Lion Training Passport. Based on their role, a minimum training requirement is defined. Individuals attend approved training sessions to meet these minimum requirements. Training sessions can be delivered in-house or by approved training organisations. Evidence of attendance is presented to the scheme administrators who update the individuals training record.

In addition to the above, at least one designated team member on the location needs to be First Aid trained. Trained means having attended an accredited Emergency First Aid at Work or First Aid at work
